## **COMMITTEE OR OFFICER REPORTS:**

Justin Wilson-Township Attorney: Ballot language was given to him to review so he can help decide how the funds in the fire fund can be used properly.

In regards to the zoning blight issues, he suggested that a procedure needs to be adopted into the ordinance that would make the blight a civil infraction. There would be a fee schedule for any tickets written by the named informer. It would not involve the township attorney unless it went to a hearing or a trial. The property owner would be found in contempt if the blight wasn't resolved. Special tax assessment could be issued if the fines aren't paid.
