

GUSTIN TOWNSHIP – ALCONA COUNTY

The Regular Meeting of the Gustin Township Board was called to order in the Village of Lincoln, on October 19, 2020 at 6:30 p.m. by Supervisor Goddard.

Present: Supervisor Goddard, Treasurer Leeseberg, Clerk LaVergne, Trustee Ginder, and Trustee Ashford. Guests: Ted Somers, Assessor, Adam Brege, Zoning Administrator and Candy Fulsher, Deputy Clerk.

**Motion by Ginder, seconded by Goddard to approve the agenda with the additions.**

**PUBLIC COMMENT:**

Assessor Somers had a handout for the board from the Department of Treasury. The subject was Board of Review and Support Staff training. It was a draft letter. The board of review members will need to be trained and complete training at least once every two years in order to meet the requirements of the audit beginning in 2022. Somers would like the board's help in making sure they get the training. Adam Brege reported on the County Courthouse. They still have reduced hours and he said that will probably happen until the end of the year. He thinks with MIOSHA and the Health Department taking over with orders it will be worse than when the Governor had them in place. He reported that Lenny Avery from the Senior Center approached him on the bed bug problem at Lincoln Manor. Brege told him it was in the Village of Lincoln and Gustin Township wouldn't have anything to do with it.

**BUSINESS:**

Supervisor Goddard presented to the board a quote from John's Home Maintenance for the 2020/2021 snow plowing season. Price is \$595.00 for 12 plows and \$45 a plow after that. There was a 2 plow credit for last year so the invoice due is \$505.00 for 2019/20 year.

**Motion by Ashford, seconded by Leeseberg to accept John's Home Maintenance snow plowing invoice for the 2019/2020 season for the rate of \$505.00 which includes the 2 plow credit from last year of \$90.00. Roll Call: Yes: LaVergne, Goddard, Ginder, Leeseberg, and Ashford. No-None.**

**Motion by Ginder, seconded by Ashford to accept John's Home Maintenance snow plowing bid for the 2020/2021 season for the rate of \$595.00. The bid is based on 12 plows. After the 12 plows it will be \$45.00 per plowing. Roll Call: Yes: LaVergne, Goddard, Ginder, Leeseberg, and Ashford. No-None.**

Received Local Road Agreement GU2001 from Alcona County Road Commission. It is for placing Recycled Asphalt on McConnell Rd. from M-72 north 4,800 feet to the seal coat. Discussion held.

**Motion by Ginder, seconded by Leeseberg to approve the Local Road Agreement GU2001 from Alcona County Road Commission for RAP placed on McConnell Rd. from M-72 north 4,800 feet to the seal coat for an estimated cost of \$31,477.00. Roll Call: Yes-Goddard, Ginder, Leeseberg, Ashford and LaVergne. No-None.**
