#### **PUBLIC COMMENT:**

Sheriff Scott Stephenson gave an update from the Sheriff Department. He said there have been a few complex cases that they have solved and he accredits that to the experienced staff. One of their deputies recently had a house fire and the community has had overwhelming support for him and his family. He is requiring his staff to go on some of the ambulance calls to keep informed of what is going on in the county; the drug testing is now being done in the lobby of the sheriff department; the fleet of vehicles they have is getting older so they have leased 2 vehicles and purchased one; they have also received and F-250 from a grant. The grant was to replace the Tahoe and for overtime pay for the employees. He told the board if we have any issues in Gustin Township to get in touch with him.
