The Regular Meeting of the Gustin Township Board was called to order in the Village of Lincoln with the Pledge of Allegiance cited, on April 19, 2021 at 6:30 p.m. by Clerk LaVergne.

Present: Clerk LaVergne, Trustee Goddard, Trustee Fulsher and Treasurer Leeseberg. Guest: Deputy Clerk Parkinson and Assessor Somers. Absent: Supervisor Ashford.

Motion by Goddard, seconded by Fulsher to approve the agenda with the additions.

PUBLIC COMMENT: None.

Motion by Goddard, seconded by Fulsher to approve the Budget Hearing Minutes and the March minutes as presented.

Treasurer Leeseberg discussed with the board the March 31, 2021 Treasurer's report. The Treasurer balances with the bank and the clerk. She noted to the board that she has settled 100% with the County Treasurer. She noted one change on the treasurer's report.

The township received the contract from C&S Dust Control. There was discussion on the contract.

Motion by Goddard, seconded by Fulsher to sign the agreement with C&S Dust Control for the township agreeing to pay 50% of up to 300' (\$141.00) worth of dust control provided by C&S dust control per parcel and to publish in the Alcona Review for one week. Rates: \$94.00 per 100' x 22'. Roll call: Yes-Goddard, Fulsher, Leeseberg and LaVergne. No-None. Absent: Ashford

The township received a bill from Millen Township for Gustin Township portion of Street light cost at M-72 and Hubbard Lake Rd. in the amount of \$151.11.

There was discussion on the Road Agreements from Alcona County Road Commission. They will be tabled until the next meeting. The bill for the Alcona County Review were discussed. There were errors in the Board of Review ads and they were incorrect. The board has not approved payment for these bills. Supervisor Ashford is to contact the review and see what they can do with the billing since it was incorrect. The clerk will hold off paying the invoices until she hears from Supervisor Ashford on the solution.

Motion by Fulsher, seconded by Goddard to approve payment of the bills in the amount of \$33,932.23 check numbers 10626-10645. Roll Call: Yes-Goddard, Leeseberg, Fulsher and LaVergne. No-None. Absent: Ashford
